Annotated Bibliography Assignment

In order to consolidate their evidence, to communicate that evidence to others, and to force themselves to think critically about their sources, writers of research projects often prepare an *annotated bibliography*.

First off, a few definitions:

Annotated Bibliography: A list of all the relevant sources a researcher has consulted, cited correctly. Each citation is followed by a paragraph that both describes and evaluates the source.

Bibliography: A list of all the relevant sources a researcher has consulted, whether or not they are directly referenced in the final document.

Works Cited: A list of only the sources specifically referenced and cited in the final document. Obviously, a works cited page will nearly always be shorter than a bibliography, and will never be longer.

<u>Please prepare an **annotated bibliography** based on the evidence you have been gathering</u>. As you write the annotations, consider the following:

- 1. Summarize the author's argument. What is his or her thesis statement?
- 2. Evaluate the relevance of the source to your paper/presentation, in terms of both content and timeliness.
- 3. Evaluate the author's authority and credibility on his or her topic.
- 4. What biases may be affecting the author's argument? Thinking about his or her intended audience may help you make this determination.
- 5. Connect this source to others cited elsewhere in your bibliography.
- 6. Describe the way this information might be used in your research paper/presentation.

Be aware that this bibliography will not be returned to you for a few days, which means that you should keep your own copy saved on your computer. Annotated bibliographies should include all the relevant sources you've consulted, whether or not you think you're actually going to refer to them. All of your sources need to be cited correctly according to the guidelines in the *MLA Handbook*. Use the MLA handout you were given, or a site like www.easybib.com to ensure that you are correctly preparing your entries. Also consult the model on the back of this sheet to get an idea of the correct format.

Assessment:

Your annotated bibliography will be assessed based on the range of sources annotated, your evaluations of their relevance, authority, credibility and bias, and the format of the document.
